SUMMARY DESCRIPTION OF JOB DUTIES AND PHYSICAL REQUIREMENTS:

<u>General responsibilities</u>: The Special Assignment Officer is responsible for performing general law enforcement functions related to law and order, including all general patrol responsibilities, crowd control, crime prevention, and the enforcement of federal laws, state laws, local ordinances, and traffic / parking regulations, arresting offenders and investigating as required. The Special Assignment Officer also supports the legal processes of the court system, including writing incident and accident reports, citations, affidavits, etc. as well as transporting prisoners and testifying in court. The Special Assignment Officer shall strive to preserve peace and protect life and property. This position responds to all calls for service and emergency assistance. This position is always the face of the City of Sturgis and shall always conduct him/herself in a manner befitting an officer of the law.

Working Environment: Special Assignment Officers work outdoors daily in an environment with a high degree of background noise (motorcycles and vehicular traffic) and that is subject to the elements, both natural (i.e. heat, thunderstorms) and manmade (i.e. motorcycle exhaust). Special Assignment Officers can be on their feet for several hours without the ability to sit down. Officers must walk when moving to a new assignment location during shift rotations. Special Assignment Officers will interact considerably with the general public and can be exposed to violence from persons who are under the influence of controlled substances, alcohol, drugs and/or are mentally unstable. Special Assignment Officers may be required to lift and move objects weighing up to 125 pounds in an emergency situation.
