Finance Officer Bueno presented the 2019 City Financial Annual Report. Motion by Waterland, second by Martinson and carried with all members unanimously voting yes to approve the 2019 City Financial Annual Report.

Motion by Waterland, second by Martinson and carried with all members unanimously voting yes to approve the CARES Act for Airport Operations. The City will receive a Federal grant for \$30,000 for a Kubota F-Series F2690 with cab lawn mower for the Airport. This will be purchased from Jenter Equipment.

Any other business:

Ryan Klima and Hayley DeAngelis asked the Council about having a Food Truck in town. They can get a permit for 30 days for a Food Truck. They would like to see the ordinance changed so that they can have the Food Truck throughout the summer. They will be on the agenda for the next meeting to discuss this.
