Tammy DesJarlais stated her concerns on the deer population especially the bucks. She asked if the City can help with this problem. Chief Vandewater said he is working with GF & P on this issue.

Deb Holland informed the Council that she is working for the BH Pioneer and they will be giving a complementary newspaper to anyone that gets the Prospector paper tomorrow morning. She would like to have the City support the BH Pioneer.

Bonnie Albert stated that the City should have the BH Pioneer newspaper as their official newspaper.

Councilor Waterland thanked Dave Smith, the Code Enforcement Officer, for helping with the Sturgis Rally Museum and the building permits that they had to apply for.

Information was discussed on the Fire District and Ambulance District initiative.
