ORDINANCE 2018-04 AN ORDINANCE AMENDING TITLE 19 – SUBDIVISION OF LAND

BE IT ORDAINED by the Common Council of the City of Sturgis, Meade County, South Dakota that Title 19 – Subdivision of Land – Chapter 19.05 – Required Improvements – Section 19.05.05 – Sewers to be amended to read as follows:

TITLE 19.05.05 SEWERS

Any subdivision within the City shall have a wastewater collection system and shall be connected to the City's sewer system. The wastewater collection system and connection shall be provided at the expense of the owner and upon completion and acceptance of the system by the City, shall become the property of the City. Once the system has become the property of the City, the City shall be responsible for maintenance of the system. Any wastewater collection system shall be designed to provide for orderly expansion into surrounding areas. All wastewater collection lines shall be constructed in a publicly dedicated right-of-way or within a recorded perpetual utility easement, unless otherwise approved by the City Council.

The design and specifications of the sanitary sewer collection system shall meet all adopted specifications. The design and specifications of the sanitary sewer collection system shall be subject to the approval of the City Development Director / Building Official Public Works Director, the City Council and the SD DENR.

WHEREAS, that ample and suitable resources exist to accommodate the orderly growth and development of the described contiguous territory as evidenced by the City's current provision of many of the City services to the adjacent area and consistent with the Comprehensive Plan; and

WHEREAS, that there is reasonable present and demonstrable future need for annexing said contiguous territory in accordance with the goals of the Comprehensive Plan; and

WHEREAS, that population and census data indicate that the City has and may experience growth or development beyond its present boundaries; and

WHEREAS, that exclusions or irregularities in municipal boundary lines are not the result of arbitrariness but are based upon existing geographical features, physical barriers, existing property boundaries, existing occupancies and uses, and existing city boundaries; and

WHEREAS, there exists a community of interest between the contiguous territory and the City of Sturgis.

NOW, THEREFORE, BE IT RESOLVED that as a result of the passage of this Resolution, following the execution of the Voluntary Annexation and Development Agreement by the parties the corporate limits of the City of Sturgis shall be and are hereby extended to include the above described property.

RESOLUTION 2018-26 CREATION OF TAX INCREMENTAL DISTRICT NUMBER FIFTEEN

WHEREAS, the Common Council of the City of Sturgis deems it necessary to create a tax incremental district, pursuant to SDCL 11-9-5, to be designated as Tax Incremental District Number Fifteen (TID #15) City of Sturgis on May 1, 2018 and includes the real property as more particularly described herein; and

WHEREAS, the Council has reviewed and considered the recommendation provided to the Council by the Sturgis Planning and Zoning Commission; and

WHEREAS, the property within the following described District meets the qualifications and criteria set forth in SDCL 11-9-8 for a tax incremental district due to not less than twenty-five percent of the proposed district being blighted as defined in SDCL 11-9-11 by the site including open space with deteriorate site improvements which hinders the prospects of future development; and

WHEREAS, the Council finds that the use of tax increment financing to promote this development is authorized by the statutes of the State of South Dakota; and

WHEREAS, the Council finds that the total assessed value of all existing Tax Increment Districts in the City of Sturgis in 2017 is \$6,314,479 and represents 1.6% of the total assessed value within the City of Sturgis; and

WHEREAS, the Council finds that the total future assessed value of TID #15 is \$750,000 or less and as such the total assessed value of all Tax Increment Districts within the City of Sturgis will be less than 10% of the total assessed value within the City of Sturgis; and

WHEREAS, the Council finds improvement of the area is likely to significantly enhance the value substantially of all the other real property in the district.

NOW, THEREFORE, BE IT RESOLVED by the City of Sturgis that the real property legally described below shall constitute the final boundaries of Tax Incremental District Number Fifteen (TID #15):

RESOLUTION 2018-28 SUPPORTING MEADE COUNTY'S APPLICATION TO THE FEDERAL LAND ACCESS PROGRAM

WHEREAS, the Common Council of the City of Sturgis has been asked by the residents of the Pine Cone Estate and area North of Sly Hill, together with the Meade County Highway Superintendent to support and sign an application for the Federal Land Access Program; and,

WHEREAS, the City of Sturgis completed a million-dollar repair of Sly Hill Road in 2009 to fix a significant road failure; and

WHEREAS, the geotechnical reports following that repair suggested drainage improvement could reduce the likelihood of future repairs; and,

WHEREAS, the same geotechnical reports stated that the geology of the hill will likely cause future failures; and,

WHEREAS, the City has advocated for several years to begin a process to identify an alternate route that would have a more suitable location that would not be subject to failures and would have a proper alignment to mitigate the current vertical and horizontal alignments; and,

WHEREAS, the County and residents north of Sturgis have not agreed with this approach and are only willing to proceed with a potential project on the existing roadway.

NOW, THEREFORE, BE IT RESOLVED by the City of Sturgis that the City agrees to jointly submit an application for federal funds to improve the existing Sly Hill roadway and will commit to the local match for the improvements within the City of Sturgis limits.

BE IT FURTHER RESOLVED the City will not commit to further improvements of the existing roadway if the grant application is not successful. Nor shall the City of Sturgis commit to a further reconstruction of the roadway if following the completion of the grant work the road should fail again.
