RESOLUTION OF ANNEXATION OF LOTS 9-30 ON OLD STONE ROAD PROPERTY

WHEREAS, Valerie and Dr. William Meirose as owners of the subject property herein, have signed and submitted a Voluntary Development and Annexation Agreement to the City of Sturgis date May 21, 2018, and

WHEREAS, the Common Council of the City of Sturgis has statutory authority pursuant to SDCL 9-4-1.1 to enter into an agreement for Voluntary Development and Annexation; and

WHEREAS, the Agreement for Voluntary Development and Annexation between the parties is for property contiguous to a portion of the present boundary of the City of Sturgis and within the

area where the growth of the City can be accommodated to provide for the orderly growth and development of the City; and

WHEREAS, that ample and suitable resources exist to accommodate the orderly growth and development of the described contiguous territory as evidenced by the City's current provision of many of the City services to the area and consistent with the previous Annexation Study; and

WHEREAS, that there is reasonable present and demonstrable future need for annexing said contiguous territory in accordance with the Annexation Study; and

WHEREAS, that population and census data indicate that the City has and may experience growth or development beyond its present boundaries; and

WHEREAS, that exclusions or irregularities in municipal boundary lines are not the result of arbitrariness but are based upon existing geographical features, physical barriers, existing property boundaries, existing occupancies and uses, and existing city boundaries; and

WHEREAS, that there exists a community of interest between the contiguous territory and the City of Sturgis.

NOW, THEREFORE, BE IT RESOLVED the Common Council for the City of Sturgis hereby declares the annexation of the following platted non-agricultural territory as defined at SDCL 9-4-5 and 10-6-31, identified as 170 Old Stone Road, Sturgis and described as follows:

Legal Description:

"Lots 9-19, both inclusive, the South twenty (20) feet of Lot 28, and Lots 29-30, both inclusive; all located in the Grandpre Subdivision, being a part of Lot A of Lot 3 in the NW ¹/₄ of the SE ¹/₄ of Section 15, Township 5, North, Range 5 East of the Black Hills Meridian, Meade County, South Dakota as shown on the plat filed in Plat Book 4 on Page 231."

NOW, THEREFORE BE IT FURTHER RESOLVED that as a result of this Resolution and the completion of the executed Voluntary Annexation and Development Agreement by the parties, the corporate limits of the City of Sturgis shall be and are hereby extended to include the above described property.

WHEREAS, The Common Council of the City of Sturgis had prepared a study pursuant to SDCL 9-4-4.1 to determine the need for annexing contiguous territory and to identify the resources necessary to extend the municipal boundaries to the area described in the study. A copy of the Annexation Study is available for public review at the Finance Office at City Hall; and

WHEREAS, the Annexation Study which has been prepared finds that certain contiguous territory described therein, and described in this Resolution, should be annexed to and included within the boundaries of the City to provide for the orderly growth and development of the City; and

WHEREAS, the property for subject to this Resolution is for property contiguous to a portion of the present boundary of the City of Sturgis and within the area where the growth of the City can be accommodated to provide for the orderly growth and development of the City; and

WHEREAS, Marie VanSickel, owner of property at 150 Old Stone Road, located adjacent to the City of Sturgis and described in greater detail below; and

WHEREAS, the area owned by Marie VanSickel and subject to this Resolution is attached as Exhibit A and incorporated herein, and consists of platted non-agricultural territory as defined at SDCL 9-4-5 and 10-6-31, more fully described as follows:

LEGAL DESCRIPTION:

Grandpre Plat Lots 20-27 Inc, N 40 FT Lot 28 in Lot A of Lot 3 NW. SE., also referred to by the Meade County Equalization Office as Parcel #11.65.02, of Section 15, T5N R5E Black Hills Meridian, Meade County, South Dakota, subject to all easements, restrictions, and reservations shown of record in the office of the Register of Deeds of Meade County, South Dakota, if any.

WHEREAS, the property described in this Resolution fits within the following statutory criteria for annexation:

That the approximate costs of the extended services to the residents in the described contiguous territory and to the City are set forth in detail in the Annexation Study subject to the City's reasonable policies, ordinances, regulations, terms and conditions in accordance with South Dakota Codified Law.
- 5. That any exclusions or irregularities in municipal boundary lines, following approval of this Resolution, are not the result of arbitrariness but are based upon existing geographical features physical barriers, existing property boundaries, existing occupancies and uses, and existing city boundaries.
- 6. That there is reasonable present need, and demonstrable future need, for annexing the subject contiguous territory in accordance with the Annexation Study.
- 7. That there exists a community of interest between the contiguous territory and the City of Sturgis.

NOW, THEREFORE BE IT RESOLVED that the property identified as Grandpre Plat Lots 20-27 Inc, N 40 FT Lot 28 in Lot A of Lot 3 NW. SE., also referred to by the Meade County Equalization Office as Parcel #11.65.02, of Section 15, T5N R5E Black Hills Meridian, Meade

County, South Dakota, subject to all easements, restrictions, and reservations shown of record in the office of the Register of Deeds of Meade County, South Dakota, if any, shall be and is hereby annexed into the City of Sturgis as provided by State Law and the corporate limits of the City of Sturgis extended to include it.
