RESOLUTION 2019-39 RESOLUTION OF CONSIDERATION FOR PLANNING COMMISSION APPLICATION REVIEW

WHEREAS, the City of Sturgis has appointed seven members to act on the Sturgis City Planning Commission as set forth by South Dakota Law;

WHEREAS, the Sturgis City Planning Commission shall carry on its function in accordance with SDCL 11-6 and have all the powers, duties, and responsibilities as set forth in said Statutes;

WHEREAS, the Sturgis City Planning Commission shall consider all Ordinances when making decisions on all applications for Variances and Use on Review applications;

WHEREAS, the Sturgis City Planning Commission shall consider all internal City management plans when making decisions on all applications for Variances and Use on Review applications;

WHEREAS, The Sturgis City Planning Commission shall consider all area covenants when deciding on all applications for variances or Use on Review applications;

WHEREAS, The Sturgis City Planning Commission shall deny all Use On review applications when it does not meet the definition of a Use on Review as found in Article VII, Section 2 in Title 18.

WHEREAS, The Sturgis City Planning Commission shall deny all Variance applications when it does not meet the definition of a Variance as found in Article VII, Section 3 in Title 18.

WHEREAS, if a property is subject to restrictive covenants, the applicant shall provide said covenants at the time of application for a Use on Review or Variance;

WHEREAS, if a property is subject to restrictive covenants that do not allow conditions granted by the approval of a Use on Review or Variance, the application shall be denied;

WHEREAS, if a property is subject to restrictive covenants that permit the conditions as allowed within the approval of a Use on Review or Variance, the applicant shall meet the conditions to be met as defined in the covenants and provide proof at the time of application;

WHEREAS, if an applicant requests a change to an existing building footprint necessitating a variance, the applicant shall provide a site boundary plan with the proposed changes submitted by a state-certified land surveyor or engineer;

WHEREAS, at the time of considering a Variance application, if a property is considered nonconforming to its zoning district, the requested changes shall be the minimum improvements necessary;

WHEREAS, a variance application is justified only if special conditions exist on the lot that create a hardship. Such hardships include exceptional narrowness, shallowness, topography, or other extraordinary or exceptional situation, condition or circumstance not created by current or previous landowners, or if the literal enforcement of the code would result in an unnecessary hardship to the landowner. A variance application may be considered when the relaxation of a restriction of the code shall provide a quantifiable benefit to the City and the surrounding neighborhood of the parcel.

WHEREAS, such hardships shall be the burden of the applicant to prove at the time of the application. The applicant shall present valid reasons for the request and show that the request will not lessen property values or interfere with neighboring properties. Hardships shall not be based on economic hardship or personal preference, but on reasonable use of the land;

WHEREAS, the applicant would not be denied the same rights and privileges enjoyed by others within the vicinity if a Use on Review or Variance is denied;

WHEREAS, for a variance application to be considered, the property must differ substantially from others within the same vicinity;

WHEREAS, approval of a Use on Review or Variance does not afford the applicant special privileges;

WHEREAS, comments from neighboring landowners will be received by the Department of Planning and Permitting in the notification process and shared with the Sturgis City Planning Commission and Sturgis City Council and commenter name withheld from public meeting.

WHEREAS, landowners within the notification zone that are adjacent to the property in question shall have higher consideration if they indicate approval or disapproval of the application;

WHEREAS, a Use on Review or Variance application, when approved, will not alter the essential character of the locality;

WHEREAS, a proposed use requested by a Use on Review or Variance application will be in harmony with the general purposes and intent of the Ordinance;

NOW, THEREFORE, BE IT RESOLVED the Common Council for the City of Sturgis hereby declares these criteria to be met by the Sturgis City Planning Commission at the time of considering applications for a Use on Review or Variance.

NOW, THEREFORE BE IT FURTHER RESOLVED that as a result of this Resolution, the Sturgis City Planning Commission shall follow these guidelines as set forth by the Sturgis City Council for the purpose of consistent development in the best interests for the City of Sturgis.

RESOLUTION 2019-38 AMENDMENT OF TAX INCREMENTAL DISTRICT NUMBER TWELVE (Dolan Creek Estates)

WHEREAS, the Common Council of the City of Sturgis created Tax Incremental District # 12 through the adoption of Resolution 2015-34 with the effective date of May 20, 2015;

WHEREAS, the Common Council also established the project plan for TID #12 which included total Tax Increment Financing of \$1,900,000; and,

WHEREAS, the Common Council of the City of Sturgis deems it necessary to amend the project plan for Tax Incremental District #12, as authorized by SDCL 11-9-18, to complete unanticipated but necessary stormwater infrastructure to complete the project; and,

WHEREAS, the Amended project plan for Tax Incremental District Number Twelve (TID #12) shall include the same property and tax base as originally established, more particularly described herein: and

WHEREAS, the Council has reviewed and considered the recommendation for an amended project plan provided to the Council by the Sturgis Planning and Zoning Commission; and

WHEREAS, the property within District #12 continues to meet the qualifications and criteria set forth in SDCL 11-9-8 for a tax incremental district; and

WHEREAS, the Council finds that not less than twenty-five percent, by area, of the real property within District #12 continues to be a blighted area or not less than fifty percent, by area, of the real property within the district will stimulate and develop the general economic welfare and prosperity of the state through the promotion and advancement of industrial, commercial, manufacturing, agricultural, or natural resources and that the total amended project value is less than 35% of the original project value; and

WHEREAS, the Council finds that the use of tax increment financing to promote development is authorized by the statutes of the State of South Dakota; and

WHEREAS, the Council finds improvement of the area is likely to significantly enhance the value substantially of all the other real property in the district.

NOW THEREFORE BE IT RESOLVED, by the City of Sturgis that the project plan for Tax Incremental District Number Twelve (TID #12) shall be amended as presented to this Council to add the necessary stormwater infrastructure.

NOW, THEREFORE BE IT FURTHER RESOLVED that said project plan for Tax Incremental District Number Twelve, City of Sturgis, shall upon passage and publication be amended and be forwarded to the State of South Dakota Department of Revenue.
