WHEREAS, a Resolution for Street Closure was passed by the City Council on June 3, 2019 for the 79<sup>th</sup> Annual Sturgis Rally; and

WHEREAS, the City has hired entertainment for the opening ceremonies that will be held at Harley Davidson Rally Point on Friday, August 2<sup>nd</sup> opening day of the annual Sturgis Motorcycle Rally; and

WHEREAS, the City is requesting open container on August 2, 2019 from 2:00 pm to 6:00 pm on Harley Davidson Way from Lazelle Street to Sherman Street and Main Street west at the west end of Rally Point to east of the Fireside Lounge on both sides of the street and Harley Davidson Rally Point.

WHEREAS, it is in the public interest to provide a safe venue for this special event; and

WHEREAS, the public event enhances visitors' experience and lead to additional sales tax generated; and

NOW, THEREFORE, BE IT RESOLVED as set forth herein that the City of Sturgis shall establish an alcoholic beverage open container area on Friday August 2<sup>nd</sup> from 2:00 p.m. to 6:00 p.m., on Harley Davidson Way from Lazelle Street to Sherman Street and Main Street west at the west end of Rally Point to east of the Fireside Lounge on both sides of the street. Open container is allowed by Section 3.02.20(C) of Sturgis City Ordinance and SDCL 35-1-5.5, for those persons legally possessing an alcoholic beverage it must be in an authorized Commemorative cup.

This area shall be marked by city barricades with clearly legible signs, provided by the City and consistent with the limitations of this Resolution, stating that the barricade marks the boundary of the open container area.
