## PROCEEDINGS OF THE STURGIS CITY COUNCIL

The Common Council of the City of Sturgis met in regular session starting at 6:00 p.m. on Monday, April 3, 2017 at the Erskine Building. Present: Alderpersons Jason Anderson, Mike Bachand, Rod Bradley, Rhea Crane, Tony Dargatz, Steve Keszler and Ronald Waterland. Also present: City Manager Daniel Ainslie and City Attorney Greg Barnier. Absent: Mayor Mark Carstensen and David Martinson.

Motion by Bachand, second by Waterland and carried with all members present voting yes to approve the agenda.

Motion by Waterland, second by Bachand and carried with all members present voting yes to go into executive session for one legal case, one contract and one personnel matter at 6:05 pm.

Motion by Crane, second by Bachand to return to regular session at 6:32 pm.

Councilor Bradley led everyone in the Pledge of Allegiance.

- Councilor Bradley proclaimed April 4, 2017 as National Service Recognition Day.
- Councilor Waterland announced that there will be an Easter Cantata on April 9<sup>th</sup> at 7:00 pm and April 11<sup>th</sup> at 7:00 pm at the Grace Lutheran Church.
- Spring cleanup will be May 1-5.
- Councilor Keszler, on behalf of the Council, expressed their sincere heartfelt condolences to the families that were affected by the tragic fire in Spearfish this past weekend.
- City offices will be closed on April 14<sup>th</sup> for the Good Friday holiday.
- The City has been awarded a SRF loan through the State for the Wastewater project. There will be more information to come.

City Manager Ainslie reported:

- The sales tax update for General Sales Tax and Capital Improvement Tax for February collected in March was up 2% MTD and was down 3.6% YTD. The Gross Receipts Tax (triple B) was down 8.9% MTD and is up 3.8% YTD.
- Payroll Changes within budget:
  - 1. Liquor Store Dept Sales Clerk part-time Rhonda Hall \$8.80.

- **b.** Consideration to approve the 2017 Dam 5K street closure on May 13<sup>th</sup> from 7 am to Noon.
- **c.** Consideration to approve amending the minutes from December 19, 2016 on the public hearing held for the SRF funding with the following language: Mayor Carstensen opened

the public hearing for the proposed DENR funding application for the Wastewater Treatment Improvements Project by asking City Manager Ainslie to describe the project to the public. Ainslie then turned the hearing over to Blaise Emerson, Director of the Black Hills Council of Local Governments, to give more detail on the project which would consist of the following components: slip lining clay tile collection system, trunk line upgrade, biosolids removal, a new treatment facility, and biosolids treatment improvements.

Emerson also stated that the proposed Sanitary/Storm Water Facilities Funding Application to the DENR was requesting \$16,647,000 in CWSRF loan funds which would be at 2.5% for a 30 year term. A surcharge will be set up to pay back this loan. Emerson also explained the overall need for the project, the engineering alternatives that were considered and costs of each, the revenue source pledged for the loan repayment, and the effect of the proposed loan on user rates.

Mayor Carstensen called for public comment. One comment was received asking for a description of how a surcharge works. After discussion, there were no complaints or concerns voiced.

## **RESOLUTION 2017-18**

## CREATION OF TAX INCREMENTAL DISTRICT NUMBER FOURTEEN

WHEREAS, the Common Council of the City of Sturgis deems it necessary to create a tax incremental district, pursuant to SDCL 11-9-5, to be designated as Tax Incremental District Number Fourteen (TID #14) and includes the real property as more particularly described herein; and

WHEREAS, the Council has reviewed and considered the recommendation provided to the Council by the Sturgis Planning and Zoning Commission; and

WHEREAS, the property within the following described District meets the qualifications and criteria set forth in SDCL 11-9-8 for a tax incremental district; and

WHEREAS, the Council finds that not less than twenty-five percent, by area, of the real property within the district is a blighted area or the development of not less than fifty percent, by area, of the real property within the district will stimulate and develop the general economic welfare and prosperity of the state; and

WHEREAS, the Council finds that the use of tax increment financing to promote development is authorized by the statutes of the State of South Dakota; and

WHEREAS, the Council finds improvement of the area is likely to significantly enhance the value substantially of all the other real property in the district.

NOW THEREFORE BE IT RESOLVED, by the City of Sturgis that the real property legally described below and known as Senior Living Project shall constitute the final boundaries of Tax Incremental District Number Fourteen (TID #14):
