## RESOLUTION 2017-22 RESOLUTION TO AUTHORIZE STREET CLOSURE OF MAIN STREET CORRIDOR FOR FREE ADMISSION EVENT STURGIS SUPERMOTO RACE ENTERTAINMENT AND EVENTS

WHEREAS, the Sturgis Supermoto Race will be held in the City of Sturgis, September 15, 2017 through September 16, 2017; and

WHEREAS, beginning on the afternoon of Friday, September 15 through all day Saturday the City of Sturgis Rally and Events Department has scheduled no-admission special events and racing to be presented on Main and other streets in Downtown Sturgis; and

WHEREAS, it is planned to construct the race track by city staff. Streets will be closed on Friday, September 15<sup>th</sup> at 2:00am; and

WHEREAS, it is in the public interest to provide a safe venue for this no-admission special events to host the many tourists that are expected to attend; and

WHEREAS, the public events that are held on this property enhance visitors' experience and lead to additional sales tax generated, sponsor and lease revenue; and

WHEREAS, The Police Department will be authorized to tow vehicles within the street closure area, starting September 15, 2017 at 2:00 am; and

NOW, THEREFORE, BE IT RESOLVED that to accommodate the safe presentation of providing this special event, a street closure for the following area will take place on Main Street from the eastern curb of 1<sup>st</sup> Street to the eastern curb of 4<sup>th</sup> Street and 1<sup>st</sup> Street from the southern curb on Main Street to Lazelle Street, and Harley-Davidson Way from the northern most curb of the alley between Main and Sherman Streets to Lazelle Street and 3<sup>rd</sup> Street from northern curb of Sherman Street to the southern curb of the alley between Main and Lazelle Streets, beginning on Friday, September 15<sup>th</sup> at 2:00 am. ## RESOLUTION 2017 -25 RESOLUTION TO AUTHORIZE STREET CLOSURE OF HARLEY DAVIDSON WAY FOR A SPECIAL EVENT TO TRAIN 2500 PEOPLE ON CPR

WHEREAS, the Sturgis Ambulance, for EMS week, will hold a special event to train 2500 people on CPR in the City of Sturgis, May 24, 2017; and

WHEREAS, on Wednesday May 24th from 9:00 a.m. to 9:00 p.m. Harley Davidson Way will be closed from Main Street to the alley contingent upon the Main Street construction schedule. Should construction prevent the closure of the street, the Ambulance Service requests use of the City sidewalks surrounding the Rally Point for their food vendors.

WHEREAS, it is planned to have an open air event space in the street,

WHEREAS, it is in the public interest to provide a safe venue for this no-admission special event to host the many participants that are expected to attend.

WHEREAS, public events that are held on this property enhances the participants experience and provides an educational benefit with a family atmosphere, and

WHEREAS, The Police Department will be authorized to tow vehicles within the street closure area, starting Wednesday, May 24, 2017 at 2:00 am

NOW, THEREFORE, BE IT RESOLVED that to accommodate this special event, Harley Davidson Way from Main Street to the alley will be closed starting at 2:00 a.m. Wednesday, May 24, 2017 contingent upon the Main Street construction schedule for Harley Davidson Way. Should construction prevent the closure of the street, the Ambulance Service requests use of the City sidewalks surrounding the Rally Point for their food vendors. All areas would be open by 6:00 a.m. on Thursday, May 25, 2017.

Motion by Anderson, second by Waterland and carried with Carstensen, Anderson, Bradley, Crane, Dargatz, Keszler, Martinson and Waterland voting yes, Bachand voting no, to approve a request from Mark Beauvais for a zero (0) side setback variance for a carport at 1805 Fulton St.

Motion by Crane, second by Bachand and carried with all members present voting yes to approve the request from Mieke Bruch for a variance of 17.46' side setback and a 6.76' rear setback for an attached garage at 810 7<sup>th</sup> Street.

Motion by Waterland, second by Crane and carried with all members present voting yes to approve the request from Richard Marsh dba Key City Moonlite Drive-in for the following use on review/variances: 1500 foot rule for the screen to not be visible from the public right-of-way; for the viewing area to not be screened by a fence, wall, or hedge six (6) foot tall on all sides; for the outdoor speakers at the front of the screen for a lawn chair seating area for a drive-in theater at 3021 Avalanche Road. The Council also approved the recommendation from Planning and Zoning of having the applicant install at least 30 feet of gravel near the entrance/exit, as well as the other high-traffic areas. This would be reviewed on a yearly basis.

### **RESOLUTION NO.2017-26**

RESOLUTION RELATING TO FINANCING OF CERTAIN WASTEWATER TREATMENT SYSTEM IMPROVEMENTS TO BE UNDERTAKEN BY THE CITY; ESTABLISHING COMPLIANCE WITH REIMBURSEMENT BOND REGULATIONS UNDER THE INTERNAL REVENUE CODE

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STURGIS, SOUTH DAKOTA (THE "CITY"), AS FOLLOWS:

1. <u>Recitals</u>.

(a) The City is has applied to the South Dakota Conservancy District for a loan from the Clean Water State Revolving Fund in the amount of \$16,647,000 to finance a portion of the cost of improvements to its wastewater treatment system (the "System"), including slip lining approximately 31,500 lineal feet of the System's remaining clay tile piping, replacement of the main 15-inch influent pipe with a 21-inch pipe, removal and disposal of biosolids that

accumulated in lagoon cell #1, a new liquid treatment system and biosolids treatment improvements (together, the "Improvements").

(b) The Internal Revenue Service has issued Section 1.150-2 of the Income Tax Regulations (the "Regulations") dealing with the issuance of bonds, all or a portion of the proceeds of which are to be used to reimburse the City for project expenditures made by the City prior to the date of issuance.

(c) The Regulations generally require that the City make a declaration of its official intent to reimburse itself for such prior expenditures out of the proceeds of a subsequently issued series of bonds within 60 days after payment of the expenditures, that the bonds be issued and the reimbursement allocation be made from the proceeds of such bonds within the reimbursement period (as defined in the Regulations), and that the expenditures reimbursed be capital expenditures or costs of issuance of the bonds.

(d) The City desires to comply with requirements of the Regulations with respect to certain projects hereinafter identified.

## 2. Official Intent Declaration.

(a) The City proposes to undertake the Improvements and to make original expenditures with respect thereto prior to the issuance of reimbursement bonds, and reasonably expects to issue reimbursement bonds for such project or projects in the maximum principal amount of \$16,647,000.

(b) Other than (i) de minimis amounts permitted to be reimbursed pursuant to Section 1.150-2(f) (1) of the Regulations or (ii) expenditures constituting preliminary expenditures as defined in Section 1.150-2(f) (2) of the Regulations, the City will not seek reimbursement for any original expenditures with respect to the foregoing projects paid more than 60 days prior to the date of adoption of this resolution. All original expenditures for which reimbursement is sought will be capital expenditures or costs of issuance of the reimbursement bonds.

#### 3. Budgetary Matters.

As of the date hereof, there are no City funds reserved, pledged, allocated on a long term basis or otherwise set aside (or reasonably expected to be reserved, pledged, allocated on a long term basis or otherwise set aside) to provide permanent financing for the original expenditures related to the Improvements, other than pursuant to the issuance of the reimbursement bonds. Consequently, it is not expected that the issuance of the reimbursement bonds will result in the creation of any replacement proceeds.

#### 4. Reimbursement Allocations.

The City's Finance Officer shall be responsible for making the "reimbursement allocations" described in the Regulations, being generally the transfer of the appropriate amount of proceeds of the reimbursement bonds to reimburse the source of temporary financing used by the City to make payment of the original expenditures relating to the projects. Each reimbursement allocation shall be made within 30 days of the date of issuance of the reimbursement bonds, shall be evidenced by an entry on the official books and records of the City maintained for the reimbursement bonds and shall specifically identify the original expenditures being reimbursed.

Motion by Waterland, second by Martinson and carried with all members present voting yes to approve the low bid from Hills Material Company for \$124,223.00 for Ballpark Road/Sherman Street 2017 Asphalt Surface Treatment project and authorize the City Manager to sign all documents and contracts. This project can spend up to the \$140,000 that was budgeted for streets.

Motion by Bachand, second by Anderson and carried with all members present voting yes to approve first reading of Ordinance 2017-06 - Title 20 - Tax.

The following bids were received for the Fort Meade Trail Phase II: North Star Construction -\$192,890; Quinn Construction Inc. - \$234,248 ; RCS - \$277,104.35; Tru-Form Construction-\$289,900; Lind Exco - \$251,775.62; Ainsworth Benning - \$373,869. Motion by Dargatz, second by Crane and carried with all members present voting yes to approve the low bid from North Star Construction for \$192,890 for Fort Meade Trail Phase II.

Any other business:

Jon Mattson, Craig Shavers, Dan Gifford and Jim Heinert spoke to the Council about Sly Hill and what the Council plans are if this road fails as this is the primary access route for land owners to the north. Other items discussed were the quality of the gravel used for maintenance, forming a committee to discuss a plan, EMS access, and federal grants and loans that would be available for repairs.

Motion by Keszler, second by Martinson and carried with all members present voting yes to go into executive session for personnel and contracts at 8:39 pm.

Motion by Waterland, second by Dargatz to return to regular session at 9:17 pm.

Motion by Dargatz, seconded by Crane and carried with all members present voting yes to adjourn the meeting at 9:18 pm.
