Motion by Martinson, second by Anderson and carried with all members present unanimously voting yes to approve a Use on Review for Terry Jensen for an in-home business at 2175 Dolan Creek Road to build and sell a tiny house.

Motion by Bachand, second by Martinson and carried with all members present unanimously voting yes to approve a Variance for Sturgis Motorsports at 2695 Lazelle St. for an 11.79' rear setback variance to allow for an addition.

Motion by Crane, second by Peterson and carried with all members present unanimously voting yes to approve a 7' Variance for Lifespring Wesleyan Church at 1706 Junction Avenue to allow for installation of parking stop blocks in the parking lot.

Shirley Wall and Bonnie Albert were present to state their concerns on this zoning change for 890 Lazelle Street.

Motion by Martinson, second by Bradley and carried with all members present unanimously voting yes to approve a Zoning Amendment for Sturgis Regional Health to rezone the south half of the property, known as Tract 2, from Medium-Density Residential to Highway Service at 890 Lazelle Street to match Tract 1, the north half of the property.

Candi Thomson and Mike Leveque asked about the 25 years of use of property in the agreement and when it will start. Ainslie said it would start when both parties had signed the agreement. Motion by Anderson, second by Peterson and carried with all members present unanimously voting yes to approve a Voluntary Development and Annexation Agreement with LPN Holdings.

Any other business:

Rachael Hale, representing Racheal Snow on a use on review that has expired, was present to ask that the code enforcement be suspended until the Council can hear more information on the use on review and she would like to know what is the policy and procedure of accepting or denying a request to be on the agenda. Ainslie said that there was nothing that the Council could act upon with the request so it was not included on the agenda.

Bonnie Albert asked that items on agenda that are not posted as part of the packet be made available at the meeting.

Motion by Bradley, seconded by Anderson and carried with all members present unanimously voting yes to adjourn the meeting at 7:55 pm.
