


In the Fall of 2020, the Sturgis City Council appointed an Ad hoc committee to address a potential need in our community.....

Idea #1

We were assigned with the idea of looking at the construction of a splash pad. We quickly determined a splash pad would accommodate only a specific, limited age

group, and support diminished.



The BEST NEWS: Total cost is LESS THAN HALF that of an outdoor aquatics center! (Many fewer zeroes!)




The Sturgis Lakeside Adventure Park could include the following:

A Project for ALL of Sturgis














The mini golf course and gathering area would be lighted during seasonal weather for extended hours, and cold weather would bring the possibility of an ice rink and sledding area.

The result is that costs are "Revenue Neutral".....or "breaking even" in layman's terms.

This project will NOT increase taxes!

- ➤ If construction bids are higher than expected, the City could delay construction for some park features until funding is available, or the City could allocate additional funds from City's savings.
- Operational costs are anticipated to be covered entirely through park fees.
- The preliminary ticket and rental rates are far lower than other comparable facilities.

To all who shall read this, Greetings.

The Aquatics & Adventure Park set forth in the Aquatics Committee Proposal of Spring, 2021 is inspired and full of potential that I believe will have long term positive effects for the City of Sturgis. Being centrally located in town and along the interstate are among the strong attributes.

Very importantly, by keeping the main function of the Sturgis Fairgrounds "recreation" for the Citizens of Sturgis, it fulfills a long-term pledge made many decades ago to keep this property a "Play Ground" for the people. This folklore is felt very strongly.

Sturgis had facilitated a "Coney Island" back in the 1890's along Bear Butte Creek. At the time this Sturgis Park boasted a park that was an attraction for many surrounding towns. It started as a half-mile race track and stables, but soon added a grand stand, a boat pond, concession stands, a band stand, outdoor bowling alley, large dance hall/roller rink, merry go round and during the winter a large ice rink took its place. In 1904/05 a flood damaged part of the facility and discouraged future growth. Soon a new site was located on a hill for the "Meade County Fairgrounds". Since July 4th of 1911 and for the next 110 years Sturgis has experienced "Thrills and Spills" on this land. It will only increase in value to the Citizens to keep this history alive.

By keeping the original start/finish line accessible and showcased as part of this new Adventure Park, we can forever stand in the foot prints of ordinary Sturgis folk who made Sturgis an American Legend.

With everything we do for others, the best reason for this project is that this Park is for us. The people that live here.

I fully endorse this proposal and encourage the Sturgis City Council to move forward with this great project.

Committee Request and Recommendation

- Request a professional design proposal from a water and mixed-recreational park engineering design firm, who would work with local engineers to put the Sturgis Aquatic's Committee concepts into a plan, including:
 - Complete an initial lake, inflatable obstacle course design and construction estimate
 - Include answer questions regarding water quality, flood plane, water availability
 - Complete an operating business plan

- ➤ City will need to provide input as to the affordability of the entrance fees into the park
- The Committee believes its proposal could largely be built using less than \$300,000 of taxpayer dollars beyond the \$200,000 already appropriated
- The Council would then be able to review the professional design and business plan and make any changes or cease the project
- ➤ The Committee would be dedicated to raising \$365,000 in funds to assist in construction
