General Rules & Regulations:

Alcohol and Illegal Drugs: The City of Sturgis strives to maintain a drug-free workplace. As a result, use of illegal drugs as well as the unauthorized use of legal drugs is strictly prohibited. Volunteers are prohibited from the use of alcohol on City property or during volunteer service. Performing volunteer duties while under the influence of drugs or alcohol is expressly forbidden. Volunteers cannot smoke inside the Animal Shelter.

<u>Animal Care:</u> Proper treatment and care of our animals is very important to Animal Shelter staff. Staff will not tolerate any behaviors that might harm or injure the animals in our care. Make sure you understand the rules with regards to approaching, socializing and caring for the animals.

<u>Dress Code</u>: Volunteers must dress in attire that is appropriate for the conditions and performance of the activity that they are scheduled to perform.

<u>Employment</u>: Volunteers are not City employees nor are volunteers paid for their volunteer services. **V**olunteers must always identify as a volunteer (and not represent themselves a City employee). Finally, in compliance with the Fair Labor Standards Act as well as to prevent conflict of interest (real or perceived), volunteers cannot serve as a volunteer and work as a paid City employee for the same Department or location.

Equipment Usage: Volunteers cannot operate City-owned vehicles or motorized equipment. If you drive your own vehicle or a third party vehicle while volunteering, you should understand that you do so at your own personal risk and liability. Telephones, copy machines, fax machines, computers, internet access, and all other City property are only to be used as permitted by Animal Shelter staff and only for authorized City business.

Financial Controls: Volunteers are prohibited from handling cash or money.

<u>Harassment:</u> Volunteers have the right to work in an environment free from all forms of discrimination and conduct which can be considered harassing. If you experience harassment, please report the incident immediately to the Animal Shelter staff. (This can include harassment by patrons and clients of the Animal Shelter.)

Personal property: The City is not responsible for personal items, so do not bring valuables.

<u>Policies and Procedures:</u> Volunteers must abide by all rules, policies, regulations, written/verbal guidelines, directions and instructions of City staff as related to the performance of their volunteer duties. Volunteers are always expressly prohibited from releasing any confidential staff or patron information.

<u>Security and access:</u> The Animal Shelter has closed circuit security cameras for your protection. Volunteers should not be at the Shelter without a City employee present. Volunteers should report any unsafe situation that they observe or any accidents occurring while volunteering.

<u>Termination of Volunteer Services</u>: The City reserves the right to cancel its need for your volunteer services at any time and for any reason.
