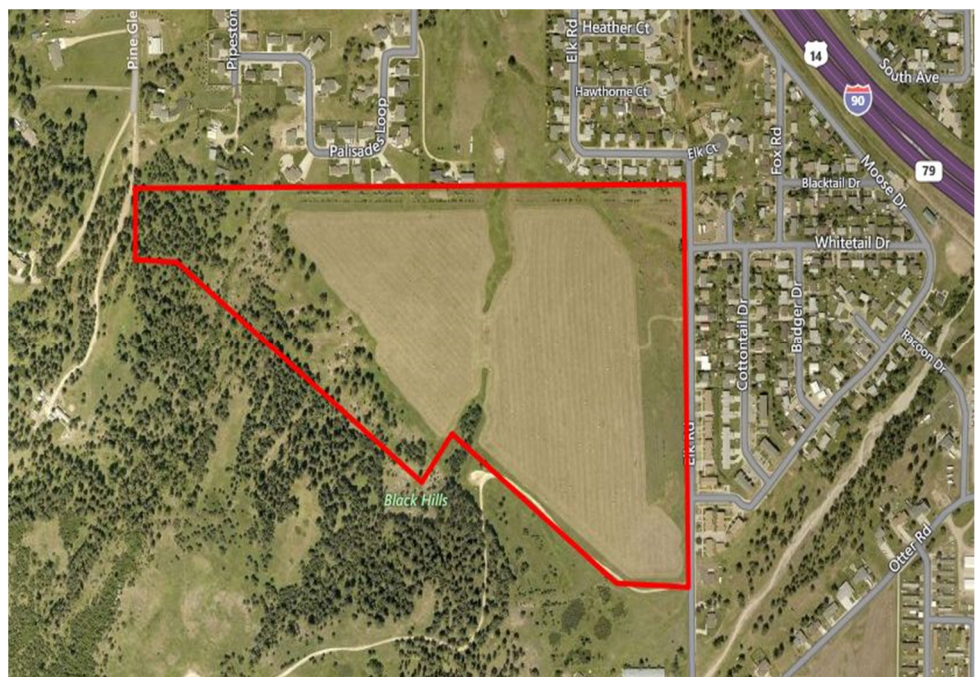

Marcotte Tract Now Officially Part of the City

On February 1, the Sturgis City Council officially annexed the 60 acre Marcotte property into the city limits of Sturgis. Located south of I-90 along Elk Road, the property was once owned by the SD Game Fish & Parks Department (GF&P) and was used as a public hunting area. In 2012, the City purchased the property from the GF&P for \$620,000 which was paid over a three year period. With the purchase now complete, the property has officially been added to the City of Sturgis.



No specific plan has been developed for the area; however future plans may include residential and recreational areas.

City Considers Selling Sturgis Watershed to Game Fish & Parks

The City of Sturgis has taken the first step in opening a formal dialogue with the SD Game Fish & Parks Department to purchase the Sturgis Watershed area from the City. At a recent City Council meeting, the City Council passed a resolution confirming their interest in the sale of the property to the state agency for use as a state park. The watershed property, also known as the Davenport Dams, is located southeast of Sturgis and is bordered by U.S. Forest Service and private property. The property consists of over 700 acres of pristine wilderness and is home to several dams. The dams were originally used as the primary water source for Sturgis. The State eventually enacted stricter controls on public water systems and the dams were no longer used. City and State officials began exploring the possibility of a property exchange when the City purchased the Marcotte property from the State. A Volksmarch held in 2015 was the first public use of the property. Feedback from the public has been in favor of opening the area to public use. According to City Manager Ainslie, the City does not have the resources to manage a remote park area; however the Game Fish & Parks Department does have resources more suited to managing this type of property. The next step in the lengthy process of selling the property to the GF&P is for an engineering study to be conducted. From that point, the state legislature and GF&P will need to decide if a park is feasible. The dams area is currently closed to public use.

Community Center to Receive Much Needed Improvements

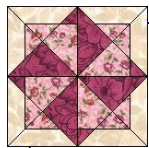
Improvements at the Sturgis Community Center are continuing into 2016 with updates scheduled for the pool and gymnasium areas.

Scheduled improvements include:

- Re-texturing of the pool walls and floor
- New paint for the pool
- New paint on the pool room ceiling
- New flooring around the pool area to help prevent slipping and will be easier to clean
- New flooring in the gymnasium

These improvements are in addition to the new doors, windows and lighting that were recently completed at the facility. New cardio and weight room equipment has also been added.

The Sturgis Code Enforcement Officer reminds campaign supporters that campaign signs are regulated within the city limits.

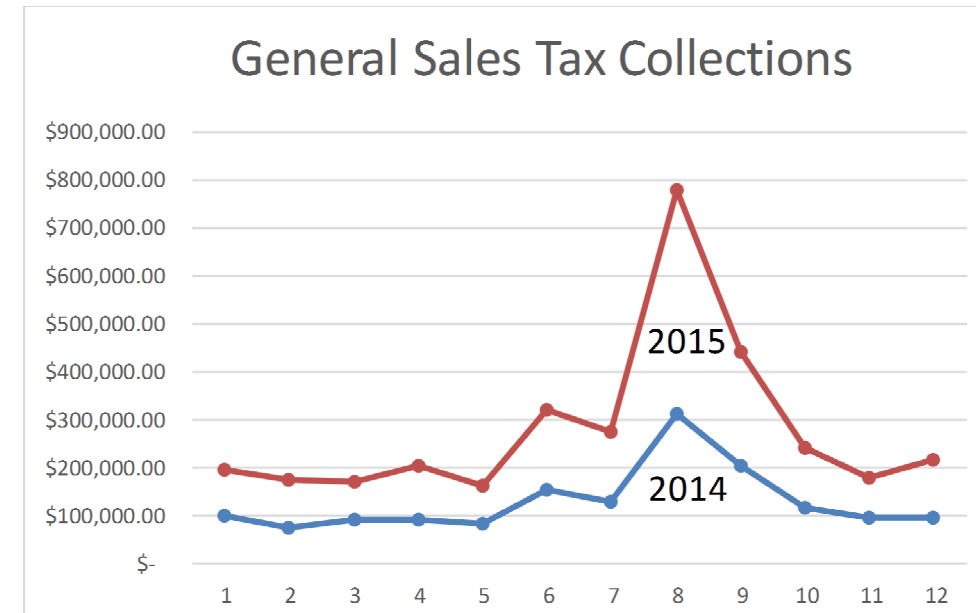
Here are the rules to follow when placing campaign signs:

- Campaign signs can only be placed on private property with the property owner's permission and can not be placed within city right of way, such as between sidewalks and streets or anywhere on city property.
- Signs can not exceed 32 square feet in size and must be removed within one week after the election. No campaigning of any sort (including signs) is allowed within 100 feet of a polling location. This is regulated by SD codified law 12-18-3 and is strictly enforced.

If signs are placed in violation of any one of the specifications listed here, they will be removed without notice by the Code Enforcement Officer. If weather conditions such as high winds dislodge the signs causing them to blow away, they will be collected with other debris and taken to the landfill.

2015 Fiscal Year Ends on a Good Note

General sales tax collections in 2015 were up significantly compared to 2014. The anniversary Rally in addition to an increase in retail activity helped grow revenues to \$1,815,541 which is an 18.8% increase for the year. The Special BBB (tourism) tax in the amount of \$363,573 was also up 20.1% from the previous year. BBB tax is collected on seasonal tourism related purchases such as car rentals, lodging and entertainment. 2016 is not anticipated to be as lucrative; however, revenue is expected to remain strong with new housing and business activity on the rise.
