### Opening Soon in Sturgis

Enviro Shield Products, Inc., a manufacturer of spill containment products for the oil industry, is relocating from Williston, ND to the Sturgis Industrial Park.



Shane Herman, CEO/ President of Enviro Shield Products, has developed a new spill containment product that can be expanded into other markets, including the motorcycle industry.

Mr. Herman plans to be fully operational in his 7,000 sq. ft. building in Sturgis in October. Two employees will relocate from Williston and another three will be hired locally. When at capacity, it is expected to have 12 full time employees. Enviro Shield is located at 1204 Sturgis Street.

Sturgis MotoCruzin USA, producer of a complete line of motorized bicycles, will start production in Sturgis in September.

Owners Chuck Jepson and Bruce Lindholm have a manufacturing and license agreement with Motoped, a Kansas City, MO based company. Sturgis MotoCruzin USA will market and produce three distinct Motoped products. Motopeds are motorized bicycles equipped with engines less than 50 cc, as well as mountain bike parts mounted to a custom frame and swing arm. They may be ridden on the street without registration, but are limited to a 30 mph speed limit. They will be located in a leased space in the Sturgis Industrial Park. They will employ five to start and expect to expand capacity in the near future with plans to build a 20,000 sq. ft. production facility.



## Area Veterans Honored During Military Appreciation Day

Two area Veterans were honored on Tuesday, August 9, as part of Military Appreciation Day at the Sturgis® Motorcycle Rally™.

Charles L. Childs, Lt. Col. Ret. joined the National Guard of North Dakota in November of 1940. He became a light machine gunner in the 164th Infantry. In 1941, while on maneuvers in Louisiana, he was accepted as an Aviation Cadet in the Army Air Corps. He trained as a Flying Cadet until July 3, 1942 when he was commissioned a 2nd Lt. and an Army Air Corps Pilot.

His first assignment as a pilot was instructing British Cadets. While in the Training Program, he instructed the operations of B-25's, B-17's and B-24's. He finally received orders for combat in B-17's to the Fifteenth Air Force in Italy.



Childs flew 37 combat missions of which 28 were as lead pilot. He received two distinguished Flying Crosses while in combat.

Three years later, he was flying on the Berlin Airlift, hauling food and coal in C-54's for the Germans and against the Russians. Having completed 196 missions into Berlin he received the Humane

Action Medal. Childs also flew in the Korean War, hauling supplies and paratroopers into the combat zone for which he received the Bronze Star.

After retiring from the service as a Lt. Col. in 1961, he became a Court Service Officer with the 7th District Court. He currently resides with his wife, Grace, in Rapid City.

Gordon B. Lease enlisted with the US Coast Guard on December 22, 1941. On December 24th, he was painting commandeered yachts at San Pedro, California, when a Japanese submarine (I-19) torpedoed the SS Absaroka. He responded on his boat, a CGR-299, and recovered one deceased and seven survivors.

During his service, Gordon accomplished many missions including time spent assigned to the Southern Assault Force Task Group 81.3 in the Gulf of Salerno, Italy, where his ship carried elements of the US 645th Tank Destroyer Battalion. Petty Officer Lease was commended by his Commanding

Officer for his actions during amphibious operations at Salerno, Italy. While under heavy bombing, Lease aided in the rescue of wounded and burned survivors from the S.S. James W. Marshall. His time in Italy also included the assault on Anzio where his action included debarking of British commandos. When finished, he was again commended for his actions during amphibious operations at Anzio, Italy while under heavy bombing attacks and artillery shelling.



In June of 1944, while serving on the USS Narragansett II the LST-381 made seven trips to the Normandy beaches, where the vessel sustained bomb damage. Boatswains Mate Gordon B. Lease was

commended by his

Commanding Officer for his actions while under enemy bombing attacks and while aiding in the loading aboard and care of 265 seriously wounded soldiers, during which time the enemy was constantly attacking.

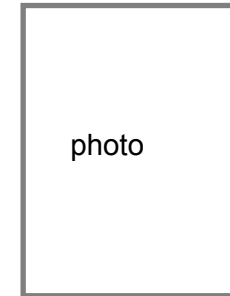
Lease was honorably discharged on June 19th, 1945, having served 3 years and 5 months. Following his WWII service, Lease worked 11 years for the City of Los Angeles as a Water Treatment Operator. On February 9th, 1948 he married his beautiful wife, Georgia. They are still married after 68 and one half years. Lease and his wife moved to Rapid City in 1963. He worked at Ellsworth Air Force Base as a Water Plant Operator, Purchasing Agent and Contracting Officer, retiring in 1984.

In June, 2013, the President of France, Francois Hollande, awarded Lease the French Legion of Honor Medal for his actions during the Normandy Campaign in 1944.

The Military Appreciation Day Ceremonies also included presentations from Brigadier General Rus Walz with the South Dakota National Guard, Colonel Gentry Boswell, Wing Commander at Ellsworth Air Force Base and Captain David Granato. A large contingent of military, including The Green Knights, rode from Ellsworth AFB to attend the ceremony. The event was scheduled to finish with a B-1 flyover of Main Street; however, the flight was postponed until Friday due to a mechanical problem.
